1. I am an attorney with the law firm of Connell Foley LLP, attorney to Hilltop Partners Redeveloper LLC (the "Applicant").

2. The Applicant seeks an amendment to the preliminary site plan granted to the General Property for the General Redevelopment Plan previously approved on May 2, 2013 for the former Irvington General Hospital Site, by Calendar Application No. PB-13-04, with the extension of said approval granted on May 23, 2019. Specially, the Applicant requests an amendment to the preliminary and final site plan approval, a major subdivision, and an amendment to the phasing for the development of residential, mixed-use, and other permitted uses as specified. The Project will include six (6) residential phases, consisting of 629 units, retail/commercial space, and associated parking. Variance relief is requested for parking and lot coverage pursuant to General Development Plan Overlay District (GDP-1) Resolution number UEZ 13-0219-5.

The Applicant also seeks an amendment to the preliminary and final site plan approval and variance relief to the second phase of the General Redevelopment Plan, a senior housing complex at 280 Park, previously approved ("Phase II"). Specifically, the Applicant seeks an amendment for the development of the 118,154 square foot senior housing complex consisting of approximately ninety-six (96) apartments units (comprising: approximately four (4) studio units, ninety-one (91) one-bedroom units and one (1) two-bedroom superintendent unit), residential amenities, a new parking garage with approximately ninety-one (91) parking spaces, seven (7) additional outdoor surface parking spaces and associated site improvements.

3. A virtual public hearing in connection with this application is scheduled for Thursday, March 25, 2021 at 7:00 p.m. in compliance with the New Jersey Municipal Land Use Law and in order to comply with the Executive Orders signed by Governor Murphy relating to the current COVID-19 pandemic, and in an effort to follow best practices recommended by the United States Center for Disease Control, (CDC).

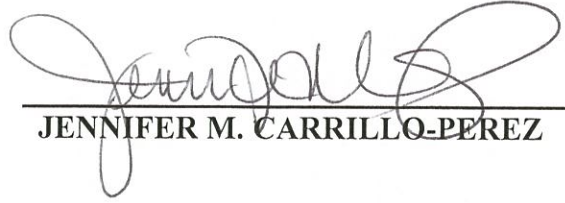
